Councillor Williams took the chair in the absence of Councillor Dawson.

Due to lateness the meeting was not quorate at 6.30pm. Item 1920/54 Update from Iain Cunningham was taken first on the agenda as no decisions would be required as a result of this item.

#### 1920/54 Update from Iain Cunningham

To receive a presentation from invited guest Iain Cunningham, Senior Planning Officer – Local Plan Team, from Bradford Council. To include information about housing requirements, designating Special Character Areas and Green Spaces and Bradford Council's review of Green Belt and Green Spaces.

Mr Quarrie arrived at the meeting at 6.40pm. The meeting became quorate from this point. Councillor Brazendale arrived at the meeting at 6.55pm.

lain Cunningham provided information about his role and that of the Local Plan team, he gave an update on local Neighbourhood Plans and the stage these are at. He explained that Bradford Council is reviewing it's 'Core Strategy' and that housing, employment, infrastructure and green initiatives are currently being reviewed. A Land Allocations Development Plan Document (DPD) will be developed and Bingley Town Council will have opportunities to comment on this in due course. This is likely to be available in mid 2020. Iain Cunningham advised that BMDC are also reviewing green spaces, and green belt, in the district and that there is likely to be a need for limited green belt release. A discussion was held about designating Special Character Areas, Iain Cunningham advised that he has consulted with colleagues in Heritage and Conservation. At present the criteria for designating Special Character Areas is not clear.

Andrew Towlerton asked Iain to confirm that Bradford MDC would undertake the SEA Screening. Iain confirmed that this was his understanding but would confirm this.

lain Cunningham advised that he has sent the Bingley Neighbourhood Plan documents to colleagues and requested feedback by the  $21^{st}$  February. He will collate this information and cascade it to the Neighbourhood Plan Working Group. He asked that a copy of the project plan be sent to him.

## 1920/54 Update from Iain Cunningham

To receive a presentation from invited guest Iain Cunningham, Senior Planning Officer – Local Plan Team, from Bradford Council. To include information about housing requirements, designating Special Character Areas and Green Spaces and Bradford Council's review of Green Belt and Green Spaces.

- a) Councillor Owen provided an update. The actions identified at the previous meeting have been undertaken. A further amendment is required to insert a statement identifying the process of agreeing, and reducing the list.
- b) Councillor Williams gave an update. He hoped to provide some reassurance to those tasked with reviewing a chapter. He advised it was not an onerous task and that the comments received should be acknowledged and considered but that it is possible that no further action is required other than to document the process.
- c) Councillor Williams advised on the current situation with AECOM. Maps have been received which can be used for the Masterplan and Design Codes. The work is ongoing. Further updates will be provided at future meetings.

#### 1920/56 Special Character Areas

- a) To receive a written update from Alan Cattell regarding the Milner Field special character area
- b) To consider if any amendments are required before recommending the Milner Field appendix, and the information about Cottingley Village, to the Planning Committee
- a) The update had been circulated prior to the meeting. The Working Group agreed to write to Alan Cattell to thank him and his colleagues for the detailed work they have done on the Milner Field supporting information.
- b) The Working Group agreed that further work is likely to be required, particularly on the information about Cottingley, but that clarification about the criteria for Special Character Areas is needed. Whilst awaiting clarification the Neighbourhood Plan Working Group will write to Cottingley Village History Society requesting their involvement.

# 1920/57 Climate Emergency

# To consider the recommendations of the Climate Emergency Working Group and how to incorporate these into the Neighbourhood Plan for Bingley

The group considered the recommendations from the CEWG and **resolved** to recommend the following to the Planning Committee and to advise the Climate Emergency Working Group of this response

1) require homes be built on council land to be energy efficient, using the Passivhaus standard or similar

It was agreed that this statement be amended to 'recommend that new homes built in the Bingley parish be energy efficient and endeavor to use the Passivhaus standard, or similar' and incorporated into the Housing chapter.

2) reduce the need to own and use a car through managing developments in the local plan

It was agreed to pass this statement to AECOM to consider inclusion within the masterplan and to respond to the Climate Emergency Working Group advising that this point should be part of Bradford Council's local plan.

3) identify area suitable for renewable energy in the local plan

The group agreed to respond to the Climate Emergency Working Group advising that it is not within the group's remit to allocate land usage, it is only for Bingley Town Council to comment on allocations made through BMDC's local plan

4) require the integration of renewable energy such as solar thermal, PV or heat pumps in local authority developments and, as much as possible within private sector developments

The group agreed to recommend that this be amended to read 'Encourage the integration of renewable energy such as solar, thermal, PV or heat pumps in all new developments' and that it be included in the Housing chapter.

# 1920/58 Village Identities

To receive the responses from Village Societies and consider how best to include the contributions within the Neighbourhood Plan.

The responses had been received from most village societies; a further request will be sent to the outstanding village for input. Councillor Steve Williams volunteered to be the owner of the chapter on Village Identities and will start to prepare the chapter and bring it back to a future meeting.

# 1920/59 Infrastructure

# To receive an update on the infrastructure chapter

An update was given. The AECOM masterplan will form the body of the infrastructure chapter. Andrew Towlerton Associates advised they will write the CIL section of the infrastructure chapter. This will be brought back to a future meeting.
