The planning committee had been notified of an appeal regarding application 18/01253/HOU, 1 Priestthorpe Hall, Park Road, Bingley. The committee noted the appeal but did not wish to make any comment beyond those made on the application. Proposed Councillor Dawson, seconded Councillor M Wheatley and agreed, all were in favour.

 - 3) Not to reduce the amount of social housing available to rent in the area and to ensure sites which provide social housing continue to do so
 - 4) To highlight the sites which a previous consultation in 2016 identified as being most appropriate for housing
 - that Andrew Towlerton Associates will draft an employment policy that protects all current employment sites, and will identify all sites allocated for employment on a map of the parish if possible.
