**Resolved** to exclude the press and public from items 1819/177 for reasons of consideration of selection procedure and confidential pricing information for the three-year floral display contract.

#### 1819/177 Floral display tender

- a) To receive the opened tenders
- b) To consider the selection procedure for the floral display contractor
- c) To receive the business plan/financial appraisal for the three-year contract
- d) To consider the risk assessment for the floral display scheme
- e) To consider which contractor to appoint
- f) To consider next steps
- a) One tender was received, and opened on Monday 3<sup>rd</sup> December, for £37,270.44 for the threeyear contract to meet all Bingley Town Councils specifications.
- b) The selection procedure was considered. Strenuous attempts had been made in 2016 and 2017 to obtain quotes for hardware, planting and maintenance but were largely unsuccessful. This was due to the maintenance element required.

The process for the tender of this contract was agreed by full council in line with the council's Standing Orders and Financial Regulations. A public notice was placed in the Telegraph and Argus on Monday 19<sup>th</sup> November and an entry placed on the Contract Finder website. The clerk had received advice from the Society of Local Council Clerks that the tender received could be accepted or the council could make further efforts to obtain quotes, for example in specialist sector magazines.

- c) **Resolved** to approve the business plan/financial appraisal for the three-year contract
- d) Resolved to approve the risk assessment for the floral display scheme
- e) Resolved to award the three-year contract for floral displays to Carlton Nurseries for £37,270.44
