- To agree to recommend increasing the figure in the draft budget for cost centre 4192: Running Costs Toilets to £24,000, to incorporate the increase in cleaning costs and the additional cleaning of the Changing Places facility.
- To agree to recommend increasing the figure in the draft budget for cost centre 4526: Climate Emergency to £13,000, to incorporate potential cost of solar panels on the Hub building.
- To agree to recommend removing the reserves figure of £40,000 for the Changing Places toilet to indicate that this will spent in the year 2021-22.
- To recommend to the Full Council the following budget and precept for 2022-23: budget of £299,275, precept of £258,457, which is £30.25 per Band D property, with the virement of funds for the Changing Places toilets as agreed at the last meeting.

Resolved to receive the update on the grant funding for the Cottingley ward as follows: guidance from Bradford Council on this funding suggested it could be used for Christmas lights, therefore Councillor Goode has liaised with Festival Lights and suggested some ideas, including replacing the ten Christmas tree decorations (£1000) and four lamppost decorations (£2200); and to agree that Councillor Goode to meet with Councillor Truelove to pursue this plan for Christmas 2022.

Resolved to agree arrangements for the internal controls inspection for Quarter 3, including to agree another internal controls member at the Full Council meeting next week, and for the Town Clerk to liaise accordingly with them and Councillor Gibbons to report back at a future meeting.
