- a) The clerk updated the committee. YLCA had advised that this is joint sponsorship, rather joint working. Additional advice is to ask CBMDC to put into writing that the bins shall not be moved out of the parish. The clerk also advised that written assurance needs to be obtained from CBMDC that if the bins are moved within the parish, this is by mutual agreement as to location. There was discussion about the requirement for a risk assessment. The committee agreed that this was not needed as the bins will become the property of CBMDC.
- b) **Resolved** that on obtaining written confirmation as outlined in a), an order be placed for the bins at the following locations:
 - 1. Keighley Road, between Bingley Grammar School and Shama Restaurant
 - 2. Adjacent to the bus stop on Canal Road, Crossflatts
 - 3. Junction of Beckfield Road/track, Cottingley
 - 4. By Nimbus adjacent to the canal tow path
 - 5. Outside the library/ 5 Rise Shopping Centre
 - 6. Wilson Road, off Park Road, Bingley
 - 7. Gilstead Moor, the turning point at the end of Moorbottom Lane
