1920/97 Grit bins

- a) To note that eight grit bins have been ordered. The clerk advised that eight grit bins had been ordered, all of which met the Bradford Council installation threshold. Seven bins had been sited by CBMDC. The bin at Tulyar Court needed further investigation.
- b) Resolved that there be further investigation on the location of the bin at Tulyar Court. Councillor Owen will look at the location for a bin at The Oval and Councillor Goode for a bin at Titania Close. Resolved that subject to satisfactory resolution of queries, the two bins be purchased for the cost of £100 each, plus VAT.
